**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

D-25-7 is used in industrial and/or commercial recirculating cooling tower systems and industrial air-washing systems to control microbiological slime. Prior to the use of D-25-7 industrial and/or commercial recirculating cooling tower systems, systems should be cleaned to remove algal growth, microbiological slime, and other deposits. Then make initial slug addition of 4.5 to 6.8 fl. oz. of D-25-7 per 1000 gal. of water to provide 40 to 60 ppm of D-25-7, based on total weight of water in the system. Repeat initial dose until control is evident. Make subsequent slug addition of 2.3 to 6.8 fl. oz. D-25-7 per 1000 gal. of water ( 20 to \_\_\_\_\_ ppm D-25-7 ) every 2 to 5 days or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of microbiological problem. Slug additions should be made in the sump of recirculating cooling tower systems.

D-25-7 is used in industrial air-washing systems which maintain effective mist-eliminating components. Prior to its use, systems should be cleaned to remove bacterial slime and other deposits. An initial slug dose of 10.6 to 13.6 fl. oz. of D-25-7 per 1000 gal. of water is recommended. Repeat initial dosage until control is evident. Subsequent slug addition of 7.9 to 13.6 fl. oz. of D-25-7 per 1000 gallons of water should be employed every 1 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and severity of the bacterial problem. Slug additions may be made to the sump or the water collection trays of the air-washing system.

**STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage or disposal.

**STORAGE:** Do not expose to extreme temperatures. Do not store more than four drums high. Leaking or damaged drums should be placed in overpack drums for disposal. Spills should be absorbed in sawdust or sand and disposed of in a sanitary landfill. Keep container closed when not in use.

**PESTICIDE DISPOSAL:** Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, mixture, or waste is a violation of Federal Law. If these wastes cannot be disposed of by use according to label directions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative of your EPA Regional Office for guidance.

**CONTAINER DISPOSAL:**

**PLASTIC:** Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in sanitary landfill, by incineration, or, if allowed by state and local authorities, by burning. If burned, stay at least 2000 ft. away.

**METAL:** Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in sanitary landfill, or by other procedure approved by state and local authorities.

**NOTE:** Changes in labeling formula differing in substance from that accepted in connection with this registration must be submitted to and accepted by the Registration Division prior to use of the label in commerce. The product is hereby registered under name with EPA label as follows:


1. All products containing the active ingredient must be labeled with the name of your product and the EPA registration number. The Agency requires all registrants to submit products to registration.
