COOLING WATER SYSTEMS: D-33-2 is used to inhibit the growth of microorganisms in industrial, commercial and institutional coolings water systems. In noticeably fouled systems, D-33-2 should be added daily at a rate of 3.3 to 4.9 ft. oz. of D-33-2 per 1000 gallons of system water (30.45 ppm) until control is evident. Subsequent additions of D-33-2 should be made to the system as needed at a rate of 1.5 to 4.9 ft. oz. of D-33-2 per 1000 gallons of system water (15-45 ppm) to maintain control. The frequency of treatment depends upon the severity of the microbiological problem. For best results the system should be cleaned prior to treatment.

INDUSTRIAL AIR WASHER SYSTEMS: D-33-2 is used inhibit the growth of microorganisms in industrial air washer systems. In noticeably fouled systems, D-33-2 should be added at a rate of 7.7 to 9.8 ft. oz. of D-33-2 per 1000 gallons of water (70-90 , pm) until control in evident. Subsequent additions of D-33-2 should be made to the system as needed at a rate of 5.7 to 9.8 ft. oz. of D-35-2 per 1000 gallons of water # (50-90 ppm) to maintain control. The frequency of treatment depends upon the severity of the microbiological problem. For best results the system should be cleaned prior to treatment.

INDUSTRIAL WATER PURIFICATION SYSTEMS: D-33-2 is used to control microbiological fouling in industrial water purification systems including reverse osmosis systems, filters, clarifiers, and ion exchange equipment. For off-line treatment, D-33-2 should be fed at a concentration of 6.4 to 16.0 ft. oz. per 1,000 gallons of water (60-150 ppm) for 4 to 8 hours. For on-line maintenance treatment, dosing of 1.6 to 3.2 ft. oz. D-33-2 per 1,000 gallons of water (15-30 ppm) for 6 to 12 hours should be made once a week or as needed to maintain control. Not intended for use in potable water systems.
