

This product is conditionally registered in accordance with FIFRA section 3(c)(7)(A) provided that you:

1. Submit/cite all data required for registration/reregistration of your product under FIFRA section 3(c)(5) 4 when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER: Corrosive. Causes eye and skin damage. This product is a potential skin sensitizer. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield and rubber gloves when handling. Harmful or fatal if swallowed.

STATEMENT OF PRACTICAL TREATMENT: If product gets in eyes, flush with plenty of water for at least 15 minutes. Call a physician. In case of skin contact, wash thoroughly with soap and water. Remove and wash contaminated clothing before reuse. If product is swallowed, call a physician or Poison Control Center. **DO NOT INDUCE VOMITING.** Rinse mouth with copious amounts of water or milk, and then give 1 or 2 glasses of water to drink. ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish. Do not apply in marine and/or estuarine oil fields. Do not discharge into lakes, streams, ponds or public waters unless in accordance with a NPDES permit. For guidance, contact your Regional Office of the Environmental Protection Agency.

PHYSICAL AND CHEMICAL HAZARDS: Do not use or store near heat or open flame.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

STORAGE: Do not use or store near heat or open flame. Do not stack more than four drums high. Drums should be opened in well-ventilated areas. Leaking or damaged drums should be placed in overpack drums for disposal. Spills should be absorbed in sawdust or sand and disposed of in a sanitary landfill. Keep container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or sludge is a violation of Federal Law. DRILLING FLUIDS: To inhibit bacterial and fungal degradation of the fluid, MTC 10-SR is incorporated in the drilling fluid at concentrations of 0.05 to 0.20% by volume.

PETROLEUM SECONDARY RECOVERY: MTC 10-SR is used to control bacterial growth in water disposal systems, and other oil field water systems. Treat 1000 gal of water treated. Additive should be made continuously or by water knockout, before or after injection pumps and injection well head. **Continuous Feed Method:** When system is satisfactorily treated, add continuously until desired degree of control is achieved. Then treat continuously, or as needed to maintain control. **Intermittent or Slug Method:** When system is satisfactorily treated, or treated 1000 gal of water for 4 to 8 hr per day and 1 to 4 times per week, or as needed.

CRUDE AND REFINED OILS: MTC 10-SR is a preservative for the control of crude oil and diesel and distillate heating oils during storage. It should be added to the storage tank at the rate of 0.6 to 6.6 fl oz per 1000 gal of oil. Additive should be added continuously to the suction side of the pump.
