This product is conditionally registered in accordance with FIFRA section 3(c)(7)(A) provided that you:



## PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

**DANGER:** Corrosive. Causes eye and skin damage. This product is a potential skin sensitizer. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield and rubber gloves when handling. Harmful or fatal if swallowed.

**STATEMENT OF PRACTICAL TREATMENT:** If product gets in eyes, flush with plenty of water for at least 15 minutes. Call a physician. In case of skin contact, wash thoroughly with soap and water. Remove and wash contaminated clothing before reuse. If product is swallowed, call a physician or Poison Control Center. **DO NOT INDUCE VOMITING.** Rinse mouth with copious amounts of water or milk, and then give 1 or 2 glasses of water to drink. Avoid alcohol.

**NOTE TO PHYSICIAN:** Probable mucosal damage may contraindicate use of gastric lavage. Measures against circulatory shock, respiratory depression, and convulsion may be needed.

**ENVIRONMENTAL HAZARDS:** This pesticide is toxic to fish. Do not apply in streams and/or estuarine oil fields. Do not discharge into lakes, streams, ponds or public waters unless in accordance with a NPDES permit. For guidance, contact your Regional Office of the Environmental Protection Agency.

**PHYSICAL AND CHEMICAL HAZARDS:** Do not use or store near heat or open flame.

## STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

**STORAGE:** Do not use or store near heat or open flame. Do not stack more than four drums high. Drums should be open in well-ventilated areas. Leaking or damaged drums should be placed in overpack drums for disposal. Spills should be absorbed in sawdust or sand and disposed of in a sanitary landfill. Keep container closed when not in use.

**PESTICIDE DISPOSAL:** Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinseate is a violation of Federal Law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at your EPA Regional Office for guidance.

**CONTAINER DISPOSAL:** Triple-rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.

## DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**COOLING TOWER SYSTEMS:** For control of bacterial and fungal slime in cooling systems, add MTC 10V3-CT to the cooling tower basin or cold water supply water in the system (40 to 50 ppm MTC 10V3-CT, based on the weight of water) if control is evident. Then treat the system with 0.7 to 3.4 fl oz of MTC 10V3-CT every 2 to 5 days, or as needed. If the system is badly fouled, treatment with MTC 10V3-CT is begun.

**RETORT SYSTEMS AND PASTEURIZERS:** For control of bacterial and fungal growth, MTC 10V3-CT is added to the first section of the pasteurizer. For best results, clean to remove old deposits prior to treatment with MTC 10V3-CT. The MTC 10V3-CT per 100 gal of water in the system. To maintain control add 2.0 to 4.0 fl oz may be made continuously or intermittently, as required to control growth.
