The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended is acceptable with the conditions listed below:

## **Proposed Amendment**

Update First Aid Statements per PR Notice 2001-1

### Conditions

Revise the label as follows:

Revise the "If Swallowed" section of the First Aid Statements to read: 1.

If Swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass fo water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

2. Revise the "If on Skin or Clothing" section of the First Aid Statements to read:

If on Skin or Clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 - 20 minutes. Call a poison control center or doctor for treatment advice.

 Separate the Precautionary Statement heading from the First Aid Statements. In addition, the precautionary heading and its statement must be grouped together to read as follows:

# PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

**WARNING:** Causes eye and skin irritation. Harmful if swallowed. Avoid breathing vapors. Do not get in eyes, on skin, or on clothing. Wash thoroughly with soap and water after handling.

- 4. The child signal word "Warning" and the "Keep Out of Reach of Children" statement must be placed under the ingredient statement.
- 5. Revise the statement "An initial slug dose of 11.1 to 18.3 fluid ounces of BUSAN 2020 per 1000 gallons of water is recommended." to read "An initial slug dose of 11.8 to 18.3 fluid ounces of BUSAN 2020 per 1000 gallons of water is recommended." to agree with the last stamped label, dated September 10, 2001.

### **General Comments**

Please note that before creating new language for the First Aid Statements, you must provide written rationale why the proposed statements should be different from that of PR Notice 2001-1.

A stamped copy of the labeling accepted with conditions is enclosed. Submit three(3) copies of our final printed labeling before distributing or selling the product bearing the revised labeling.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish and aquatic organism. Do not contaminate water by cleaning of equipment or disposal of waste. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. ### STORAGE AND DISPOSAL

#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

BUSAN 2020 is used to control algae, bacteria, and fungi in recirculating commercial and industrial cooling towers and recirculating cooling systems. Prior to its use, systems should be cleaned to remove existing algal growth, microbiological slime, and other deposits. An initial slug addition of 2.9 to 7.3 fluid ounces of BUSAN 2020 per 1000 gallons of water to provide a concentration of 24 to 60 parts per million of BUSAN 2020 based on the total weight of water in the system, is recommended. Repeat initial dosage until control is evident.

Subsequent slug additions of 0.73 to 7.3 fluid ounces of BUSAN 2020 per 1000 gallons of water (6 to 60 parts per million of BUSAN 2020) should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the seventy of the microbiological problem. BUSAN 2020 is used to control bacteria in industrial air-washing systems that maintain effective mist eliminating components. Prior to its use, systems should be cleaned to remove bacterial slime and other deposits. An initial slug dose of 11.1 to 18.3 fluid ounces of BUSAN 2020 per 1000 gallons of water is recommended. Repeat initial dosage until control is evident. Subsequent stug additions of 7.5 to 18.3 fluid ounces of BUSAN 2020 per 1000 gallons of water should be employed each 1 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and severity of the bacterial problem. Slug additions may be made to the sump or the water collection trays of the airwash systems.

BUSAN 2020 is used to control the growth of algae in recreational water systems such as pools, spas, whirlpools and hot tubs. BUSAN 2020 can also be used to control aloae growth in decorative fountains and ponds. For optimum results, systems containing heavy algae growth, should be cleaned prior to using BUSAN 2020.

For recreational water systems having just visible algae growth add 11 to 30 fluid ounces of BUSAN 2020 per 10,000 gallons of water. Maintain re-circulation on the pool while treatment and remove settled algae debris. Repeat treatment 3-5 days until algae growth has been removed. Brush walls and floors between applications. For treatment of freshly cleaned and filled recreational water systems add 6 to 11 fluid ounces of BUSAN 2020 per 10,000 gallons of water. Subsequent additions of 2 to 4 fluid ounces of BUSAN 2020 per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

For treatment of freshly cleaned and filled recreational water systems add 6 to 11 fluid ounces of BUSAN 2020 per 10,000 gallons of water. Subsequent additions of 2 to 4 fluid ounces of BUSAN 2020 per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

For decorative fountains and ponds having just visible algae growth add an initial dose of 0.6 to 2 fluid ounces of BUSAN 2020 per 1,000 gallons of water. For treatment of freshly cleaned decorative fountains or ponds. Add 0.2 to 1.0 fluid ounces of BUSAN 2020 per 1,000 gallons of water every 5 to 7 days for maintenance.

BUSAN 2020 will control and prevent most algae growths during off-season winter months when recreational water systems are not in use. For systems which have been properly treated during the summer months and are free of visible algae growth, add 10 to 20 fluid ounces of algaecide per 10,000 gallons of water. If at the end of the swimming season systems have some visible algae growth, add 20 to 30 fluid ounces per 10,000 gallons of water. It is necessary that a uniform distribution of algaecide is obtained throughout the water for maximum effectiveness. If recreational water systems such as pools and spas are not covered during the off-season, it may be necessary to repeat the treatment one or more times during the season. BUSAN 2020 is compatible at use levels with other chemicals normally employed to treat recreational water systems. To prevent water cloudiness during treatment, do not add chlorinated shock treatments while applying BUSAN 2020. Do not mix BUSAN 2020 with concentrated dry or liquid chlorine products.
