

Technical assistance in applying TCMTB 5WB for microorganism control as described in the following upon request when a description of the problem is provided

LEATHER: TCMTB5WB is used at treatment rates of 1.5 to 12.0 lb/1000 lbs of white weight stock to prevent the bacterial or fungal degradation of salt-cured hides and skins and to prevent mold growth on chrome-or vegetable-tanned hides and skins. For treating hides cured with dry salt, TCMTB 5WB should be sprinkled on the hides or should be mixed with the salt before it is applied to the hides. For treating fanned hides, TCMTB 5WB should be dispersed in water and added to the pickling solution or to the tanning liquor at the start of the tanning operation. For preservation of leather-finishing pastes and fat liquors. TCMTB 5WB is added to the pastes at 0.60 to 1, 5% by weight of treated paste and mixed to ensure adequate dispersion

PULP MILLS: To protect wood chips from fungal degradation during storage, TCMTB 5WB is used at 3.0 to 12.0 lb/ton of oven-dry wood. It can be applied through a water shower of spray located in the pneumatic conveyor carrying chips from the chipper to the storage pile. For preservation of wel lap or sheet pulp, TCMTB 5WB is used at 3.0 to 24 lb/ton of oven-dry fiber. It is applied to the surfaces of the dewatered pulp by means of sprays or applicator rolls.

PAPER MILLS: To control bacterial and fungal growth on paper and paperboard machines, TCMTB 5WB is added to the white water or stock at 0.6 to 3.0 lb/ton of dry paper or paperboard produced. To make mold-resistant paper or paperboard, TCMTB 5WB is used at 0.3 to 0.6 lb/1000 sq ft of surface. For coated paper or board, TCMTB 5WB is incorporated in the coating mix prior to application of the coating. For uncoated paper or board, TCMTB 5WB is dispersed in water, surface-sizing solution, or other solvent and applied to the surface to be protected by means of an i applicator roll. For the preservation of agricultural mulch paper, TCMTB 5WB is used at 9 to 30 lb/ton air-dry paper. PESTICIDE STORAGE: Do not expose to extreme temperatures. Do not stack more the mulch paper by tub-sizing methods or by means of sprays or applicator rolls before the paper is coated. If these wastes COOLING TOWERS: TCMTB 5WB is used to protect cooling tower wood against soft or surface rot and internal or dry rot. It is applied by spraying or painting a dispersion containing 3.0 to 4.2% TCMTB 5WB in water onto the clean wood surfaces. The amount applied should provide 3.6 to 4.8 lb TCMTB 5WB per 1000 sq ft of wood surface. Soft or surface rot can also be inhibited by periodic shock doses of TCMTB 5WB to the recirculating cooling water at the tower basin or cold well. The dosage should provide 7.5 lb of TCMTB 5WB per 1000 gal of water and the bleedoff should be stopped for 4 to 6 hr after treatment. The shock treatment should be impeated every four months.

CONTAINER DISPOSAL: Triple rinse (or equivalent). Then offer for recycling or COOLING WATER: TCMTB 5WB is used to control algae, bacteria, and fungi in industrial recirculating cooling water systems. Before treatment is begun, the system should be cleaned thoroughly to remove old algae growth, microbiological slime, and other deposits. The system should then be drained, flushed, refilled with water, and treated with an initial dose of 3.6 to 22.2 fl oz TCMTB 5WB per 100, gal water in the system. Subsequent additions of 1.2 to 7.2 ft oz per 1000 gal should be made every 1 to 5 days, decending on amount of bleedoff and seventy of microbiological fouling.

COATINGS: TCMTB 5WB is used to protect coatings against disfigurement and deterioration by fungi. TCM $^{\circ}$ B 5WB is added at 3 to 30% based $^{\circ}$ on the total weight of coatings. For solvent-based coatings the TCMTB 5WB can be dissolved in aromatic solvents or combinations of aromatic and alignatic solvents and added in the let down or added directly to the finished paints. For water-thinned latex emulsion coatings, the TCMTB 11 5WB can be premixed with the wetting agent and added to the pigment sturry or simply added to the let down or finished paint.

DRILLING FLUIDS: To inhibit bacterial and fungal degradation of the fluids or muds used in the drilling of wells, TCMTB 5WB is incorporated in the drilling fluid at concentrations of 0.3 to 1, 5% based on the total weight of the fluid.

PETROLEUM SECONDARY RECOVERY: TCMTB 5WB is used to control sulfate-reducing bacteria, slime-forming bacteria, and fungi in oil-field to the control sulfate-reducing bacteria, slime-forming bacteria, and fungi in oil-field water, polymer, or micellat floods, water-disposal systems, and other oil-field water systems at dosage rates of 1.2 to 22.2 floz of TCMTB SWB per 1000 gal of water treated. Additions should be made continuously or intermittently by means of a metering pump at the free water knockouts, before or after injection pumps and injection well headers. Continuous Feed Method: When system is noticeably fouled, add 3.6 to 22.2 fl oz (A) TCMTB 5WB per 1000 gal of water continuously until desired degree of control is achieved. Then treat with 1.2 to 7.2 fl oz TCMTB 5WB per 1000 gal of water continuously, or as needed to maintain control. Intermittent or Slug Method: When system is noticeably fouled, or to maintain control, add 3.6 to 22.2 ft oz TCMTB 5WB per 1000 pal of water for 4 to 8 hr per day and 1 to 4 times per week, or as needed to maintain control. CUTTING FLUIDS: TOMTB 5WB is used to inhibit bacterial and fungal degradation of water-based and water-soluble or emulsifiable cutting fluids and coolants used in metalworking operations. It should be added to the cutting fluid at a rate that will provide 600 to 1500 parts per million TCMTB 5WB (weight/weight) after final dilution of water, TCMTB 5WB can be added after dilution or to the concentrate before dilution. To prevent fundal growth on the inside walls of the diluted metalworking fluid storage tanks, higher concentrations of TCMTB 5WB are needed. For this application, it is recommended that TCMTB 5WB be added to the diluted fluid as it is prepared to provide a concentration of 3000 to 7500

REFINED OILS: TCMTB 5WB is an oil-soluble preservative for the control of bacteria and fungi that cause the degradation of refined fuel oils during storage. It should be added to the cit as it is being transferred from the shipping container to the storage tank at the rate of 16 to 32 ft oz TCMTB 5WB per 1000 gal of oil, Addition should be made batchwise where mixing occurs or continuously to the suction side of the transfer pump.
