



3. The Confidential Statement of Formula dated December 15, 1997, is in compliance with PR Notice 91-2, agrees with the label and is acceptable.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

LEATHER PRESERVATIVE

Busan 116 is recommended for the prevention of mold, bacteria and fungi in the storage, transport and processing of wet leather stock such as pickled, chrome-tanned and vegetable-tanned leathers. Busan 116 can be used at the dosages noted below to prevent and control microbiological growth. The dosage level used will depend on storage conditions and the level of protection required.

Dosage rates of 0.001 to 3.0 lbs. of Busan 116 per 1000 lbs. of wet hide weight are used for prevention of mold, bacteria and fungi on chrome-tanned and vegetable-tanned hides and skins. Busan 116 should be pre-diluted in water 5 to 20 times and then added to the pickling solution or to the tanning liquor at the beginning of the tanning process or the rinse water in a post tanning refloat.

For preservation of leather finishing pastes and fat liquors, Busan 116 is added to the paste or fat liquor at a dosage rate of 0.05% to 1.0% by weight of the treated paste or fat liquor and mixed thoroughly to insure adequate dispersion.
