Fountains and ponds with just visible algae growth require an initial dose of 1.0 to 2.0 fluid ounces of this product per 1000 gallons of water. To treat a freshly cleaned and filled fountain and

ponds, add 0.5 to 1.5 fluid ounces of this product per 1000 gallons of water. For maintenance dosages, add 0.2 to 0.5 fluid ounces of this product per 1000 gallons of water every 5 to 7 days as needed. Make sure this product is added at a point where it can be uniformly distributed, this product may be used in fountains and ponds treated with chlorine chemicals, but do not mix this product with concentrated dry or liquid chlorine products.
