NOTE: This product is **not** being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time.

DECORATIVE FOUNTAINS and PONDS: this product is used to control the growth of algae in decorative fountains and ponds that do not contain fish. Manually clean heavy growths of algae prior to treatment. Fountains and ponds with just visible algae growth require an initial dose of 1.0 to 2.0 fluid ounces of this product per 1000 gallons of water. To treat a freshly cleaned and filled fountain and

ponds, add 0.5 to 1.5 fluid ounces of this product per 1000 gallons of water. For maintenance dosages, add 0.2 to 0.5 fluid ounces of this product per 1000 gallons of water every 5 to 7 days as needed. Make sure this product is added at a point where it can be uniformly distributed. this product may be used in fountains and ponds treated with chlorine chemicals, but do not mix this product with concentrated dry or liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE AND DISPOSAL: Keep container closed when not in use and away from children and persons unfamiliar with its use. Store away from food. Leaking or damaged containers must be placed in a plastic bag and discarded in the trash. Mop up spills with clean water. Nonrefillable container: Do not reuse or refill empty container. Wrap container and place in trash.
