- d. Delete your 35 day flea relief claim. You may carry the following claim:

This product will kill fleas up to 14 days on dogs and will kill ticks for 4 days on dogs.

- e. Add the following to "Hazards to Humans and Domestic Animals":

Do not use on nursing puppies or puppies under 3 months of age. Do not use on old, sick, or debilitated dogs. Do not spray in eyes, face, or genitalia.

- f. The statement should read:

"Do not use this product in or on electrical equipment due to the possibility of shock hazard."

- g. Under precautions add:

Allow treated surfaces to thoroughly dry before using.

- h. It is not clear that your product is a pump spray. Since this product is intended for homeowner use it must be applied directly from container and contain a type of sprayhead attachment when marketed. Please explain.

- i. Precautions are too stringent for a product applied as a dip (direct contact). Revise as follows:

Harmful if swallowed. May cause eye injury. Avoid contact with eyes. Wash thoroughly. . . , etc.

3. In reference to the Confidential Statement of Formula (CSF): The pH is listed as N/A on the CSF but on the data matrix, pH is listed as 7. Please explain.

4. Submit five (5) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 Enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

Applied as a Dip: Wet the dog with water before treatment. Sponge or pour on the dog until its fur and skin are thoroughly wet, making sure that the animal's entire body is treated, including the legs and underbody. Do not treat the dog's face. Avoid contact with genitalia.

TO CONTROL FLEAS AND TICKS ON PREMISES:

Apply as a direct spray to control accessible stages of fleas and ticks. Spray to lightly dampen absorbent surfaces or to the point of runoff on non-absorbent surfaces. Thoroughly spray infested areas, pet beds and resting quarters, cracks and crevices, along baseboards, moldings and window and door frames, as well as localized areas of floor and floor covering. Repeat as necessary.

TO CONTROL CRAWLING INSECTS:

Apply as directed to control accessible stages of crawling insects including, but not limited to, cockroaches, ants, fleas, ticks, spiders, silverfish, and crickets. Spray to thoroughly wet exposed insects. Direct spray into hiding places, cracks and crevices, along baseboards, and around door and window frames.

STORAGE AND DISPOSAL

STORAGE: Store in original container in a cool, dry place inaccessible to children and pets.

DISPOSAL: Do not reuse container. Wrap container in several layers of newspapers and discard in trash.
