GENERAL CLASSIFICATION

For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

Disinfection - To disinfect hard, non-porous surfaces, add 1 oz. per gallon of water. Treated surfaces must remain wet for 10 minutes. Fungicidal Control - **LONZA FORMULATION S-18** is an effective fungicide against *Trichophyton mentagrophytes* (the athlete's foot fungus) when used on surfaces in areas such as locker rooms, dressing rooms, shower and bath areas, exercise facilities, etc. at 1 oz./gallon

Mold and Mildew Control. At 1 oz./gallon, **LONZA FORMULATION S-18** will effectively inhibit the growth of mold and mildew and the odors caused by them when applied to hard, non-porous surfaces (as indicated in general instructions above). Allow to dry on surface and repeat when mildew growth returns.


