**APPLICATION INFORMATION**

Select the proper dilution of THIS PRODUCT for your use from the directions below. Apply the use solution with a clean mop, sponge, cloth, squeegee or mechanical scrubber.

Prepare fresh use solutions daily. Do not reuse solutions. Discard solutions when they become visibly soiled. For disinfection thoroughly wet the surfaces to be treated. Surfaces must remain moist for at least 10 minutes to assure proper germicidal action.

This product may be used for cleaning and disinfecting hard, non-porous, inanimate environmental surfaces, (glass, metal, glaze, porcelain, linoleum, tile, smooth leather, varnished and finished wood surfaces), walls, floors, appliances and furnishings.

**CLEANING**

To Clean and Deodorize or to Pre-clean Prior to Disinfection. Depending on the soil level of the area to be cleaned, use 3 to 12 oz. of THIS PRODUCT per gallon of water.

**DISINFECTING**

Hospitals, Veterinary Clinics, Nursing Homes. Use 7 1/2 oz. of THIS PRODUCT per gallon of water (1 part to 16 parts water) for one-step cleaning and disinfection of areas with light to medium soiled loads. For heavily soiled areas, pre-clean as described above and then disinfect with THIS PRODUCT at 6 oz. per gallon (1 part to 10 parts water).

Industrial areas, Barber Shops, Restroom, Restaurants, Food and Meat Processing Plant (non-lead processing areas). Other Non-Medical uses: Pre-clean surface. Then, disinfect with a solution of 4 oz. THIS PRODUCT in a gallon of water (1 part to 31 parts water). Alternatively, clean and disinfect in one operation using 7 1/2 oz. THIS PRODUCT per gallon of water.

For deodorizing garbage cans, garbage trucks, industrial waste receptacles, and garbage handling equipment. It is especially important to pre-clean the product to perform properly. Then, apply a wetting concentration of 16 oz. of THIS PRODUCT per gallon of water.

For mold control: Follow directions for hospital disinfection. Repeat treatment every seven days, or when new growth appears. THIS PRODUCT may be used through automatic floor scrubbing equipment. THIS PRODUCT must not be used on flux contact surfaces.

**DISPOSAL:** Do not reuse empty container. Wrap and put in trash collection.
