If this happens and the patient is conscious, immediately administer activated charcoal (six to eight heaping teaspoonfuls) with water and get medical attention.

If on skin: Immediately wash with plenty of soap and water. Get medical attention if irritation develops.

In inhaled: Remove individual to fresh air. If breathing difficulty occurs, get medical attention. If not breathing, provide cardiopulmonary resuscitation assistance (mouth to mouth) and call a physician.
