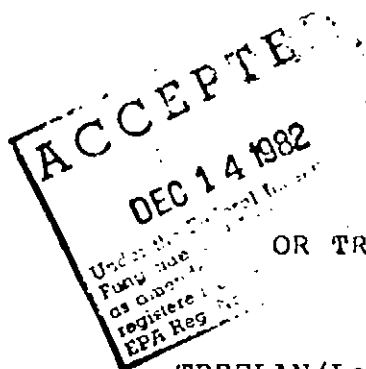

TREFLAN/LASSO® TANK MIX PREPLANT INCORPORATED
OR TREFLAN PREPLANT INCORPORATED WITH LASSO SURFACE APPLIED
FOR WEED CONTROL IN SOYBEANS

TREFLAN/Lasso® tank mixed and TREFLAN preplant incorporated followed by Lasso surface applied control those weeds listed on the TREFLAN label plus these additional weeds:

Galinsoga	Witchgrass
Nightshade, black*	Pusley, Florida
Nightshade, hairy*	Nutsedge, yellow**
Rice, red**	

Additional weeds partially controlled by this combination include:

Beggarweed, Florida	Sida, spiny (teaweed)
Ragweed, common	Smartweed

For TREFLAN/Lasso tank mix: Follow recommended soil preparation recommendations for TREFLAN. Apply TREFLAN/Lasso in a minimum of 15 gallons of water or liquid fertilizer per acre. Set incorporation equipment to work the soil no deeper than four (4) inches. Apply the tank mix up to seven (7) days prior to planting.

For TREFLAN preplant incorporated followed by Lasso surface applied: Apply and incorporate TREFLAN according to recommended soil preparation application and incorporation procedures for TREFLAN. Refer to the Lasso label for additional application directions, cautions and precautions prior to use.

* Use a minimum of two and one-half (2 1/2) quarts of Lasso to control these weeds.

**Use three (3) to four (4) quarts of Lasso per acre applied alone or, on medium and fine textured soils, in tank mix combination preplant incorporated only for control of these weeds.

Broader spectrum control of additional weeds may be obtained by applying TREFLAN or Lasso in combination with broadleaf herbicides. Check the tank mix product, TREFLAN or Lasso labels for additional directions for use, cautions and precautions prior to use.

The amendment referred to above, submitted in connection with registration under FIFRA is acceptable, provided that you:

1. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
 - a. Delete "Broader spectrum control of additional weeds may be obtained by applying Treflan or Lasso in combination with broadleaf herbicides." Change the next sentence to "Check the Treflan and Lasso labels for additional directions for use, precautions and limitations prior to use." You may propose additional tank mix recommendations consistent with the conditions specified in PR Notice 82-1.
2. Submit five (5) copies of your final printed labeling before you release the product for shipment.

A stamped copy of the labeling is enclosed for your records.
