Dear Ms. Hantak:

The revised labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable provided that you make the following changes and submit one (1) copy of final printed labeling to us before you ship product.

1. As stated in our September 30, 1998, letter, remove all references to closet because all sizes under this registration (10 oz., 5 oz., 4 oz., and 7 oz. ) are less than 16 ounces and there is not enough product to treat an entire closet. Although you have deleted most references, two still remain.
2. On Item No. 504W (ENOZ PARA Moth Balls, 4 oz.), correct "5 oz." with "4 oz.", and "15 cubic feet" with "13 cubic feet" under Application Directions.

This registration will be subject to cancellation in accordance with FIFRA sec. 6(e) if you do not comply with these conditions. Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A stamped copy of the labeling is enclosed for your records.
