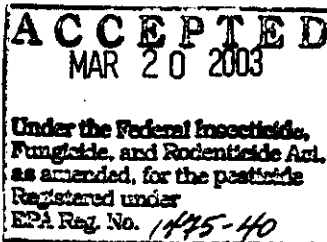

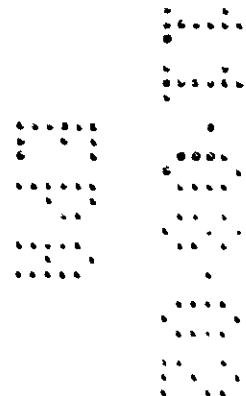

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Use Restrictions: This product can treat up to 12.5 cubic feet for moth protection and 6.25 cubic feet for mildew protection. Kills Clothes moths and Carpet beetles and their eggs and larvae in clean, airtight containers, such as chests, trunks, and garment bags. Do not use dry cleaning bags, garbage bags or other containers that allow vapors to escape into occupied rooms. This product can damage some plastics, use only in polyethylene or polypropylene containers. Paradichlorobenzene should not be mixed or placed in contact with other moth preventive chemicals.

Pre-Application Directions: Before storing, dry clean, wash or brush articles to be protected. Prevents moth infestation regardless of fabric type.

Application Directions: Open package. Remove cake and punch out all vent holes on package. Unwrap the cake, and while holding cake by the cellophane wrapper, transfer back into the package. Place the filled package at the top of the storage container. The vapors work downward. Keep product in airtight space for a minimum of 7 days.

When cake has dissipated replace with new unit. Odor quickly vanishes when articles are aired.
