Dear Ms. Hantak:

The revised labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable provided that you make the following changes and submit one (1) copy to us before you ship product:

1. Since the product is less than 16 ounces, remove all references to closet because there is not enough product to treat an entire closet.
2. Add the number of ounces of product to the label.
3. Change the statement "Prevents moth infestation regardless of fabric type" to "For use only on cloth containing wool or wool blends."
4. In the storage and disposal section, correct the statement "do not empty container..." to "do not reuse empty container..."
5. In the Notice section, performed is misspelled.
6. Revise the Ingredient Statement as follows:

ACTIVE INGREDIENT:

Paradichlorobenzene . . . .99.59%

INERT INGREDIENT : . . .0.41%

TOTAL 100.00%

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions. A stamped copy of the labeling is enclosed for your records.

The Agency has determined that the Confidential Statement of Formula (CSF), dated 5/21/98, which was submitted under FIFRA, as amended, is acceptable. A copy of this CSF has been placed in our file for this product. All previous versions are obsolete. If you have any questions, please contact Amy Caicedo on (703) 308-9399.

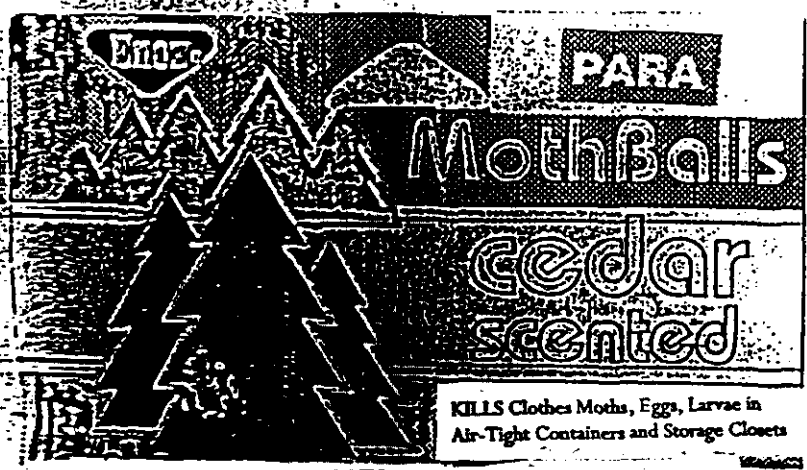

**DIRECTIONS FOR USE:**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**KILLS CLOTHES MOTHS AND CARPET BEETLES**

**Use Restrictions:** Kills clothes moths (larvae and adults) and carpet beetles in clean, air-tight containers (e.g., chests and trunks) and garment bags. Do not use in containers, dry cleaning and garbage bags, or closets that allow vapors to escape into occupied rooms. Do not use this product with any other moth control chemical. As Paradi-chlorobenzene damages some plastics, use only in polyethylene or polypropylene containers.

**Pre-Application Directions:** Before storing, dry clean, wash or brush articles to be protected. **Prev.** moth infestation regardless of fabric type.

**Application Directions:** Apply product in clean, air-tight containers listed above at the rate of 1 bag (7 oz.) for 20 cubic feet of confined space. For example, chest or trunk 3 feet high, 4.5 feet wide and 1.5 feet deep (i.e. 20 cubic feet).

**Post-Application Directions:** Keep product in air-tight space for a minimum of seven (7) days. Odor dissipates when treated articles are aired.

**Retreatment:** Since moths are active all year, replenish air-tight containers, bags, and closets 2 times a year or when product has dissipated.

**WARNING:** Causes substantial but temporary eye injury. Harmful if swallowed or absorbed through skin. Causes eye, skin, and respiratory tract irritation. Wear safety glasses. Do not get in eyes or on clothing. Avoid contact with skin. Wash thoroughly with soap and water after handling. Remove contaminated clothing wash before reuse.

**NOTICE:** This product contains a chemical known to the State of California to cause cancer. This conclusion was based on scientific studies performed on laboratory animals.

**FIRST AID: IF SWALLOWED:** Call a physician or Poison Control Center. Do not induce vomiting. Drink promptly a large quantity of water. Avoid alcohol.
