Dear Ms. Hantak:

We have received the above revised labeling and Confidential Statement of Formula (CSF), submitted under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA). The results of our review of these documents follow.

A. Revised Labeling. The labeling referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable provided that you make the following changes and submit one (1) copy to us before you ship product:

1. Change the statement "Prevents moth infestation regardless of fabric type" to "For use only on cloth containing wool or wool blends."
2. In the Warning Section, after "Do not induce vomiting" add "or give anything by mouth to an unconscious person."
3. In the First Aid section, add "Note to Physician:" before "Probable mucosal damage..."
4. Revise the Ingredient Statement as follows:

INERT INGREDIENTS: . . .	0.41%
TOTAL	100.00%

A stamped copy is provided for your records.

B. Revised CSF. The Agency has determined that the CSF dated May 21, 1998, is acceptable. A copy of this CSF has been retained in our files for this product. All previous versions are obsolete.

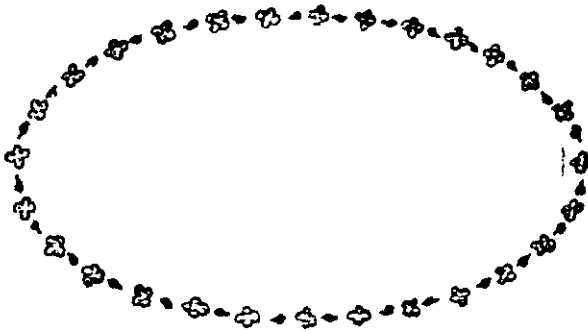

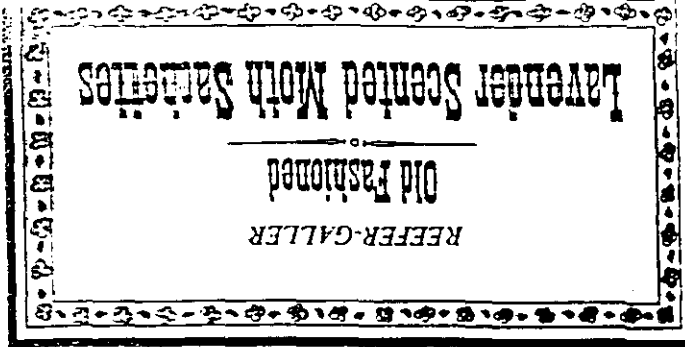

**DIRECTIONS FOR USE :**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.  
**KILLS CLOTHES MOTHS AND CARPET BEETLES**

**Use Restrictions:** Kills clothes moths (larvae and adults) and carpet beetles in clean, air-tight containers (e.g., chests and trunks), drawers, packages and other closed receptacles. Do not use in containers, dry cleaning and garbage bags, or closets that allow vapors to escape into occupied rooms. Do not use this product with any other moth control chemical. As Paradi-chlorobenzene damages some plastics, use only in polyethylene or polypropylene containers.

**Pre-Application Directions:** Before storing, dry clean, wash or brush articles to be protected. Prevents moth infestation regardless of fabric type.

**Application Directions:** Leave crystals in bags and place on top of articles in area desired. Apply product in clean, air-tight containers listed above at the rate of 1 sachette bag (2 oz.) for 6 cubic feet of confined space. For example, a chest 1.6 feet high, 2 feet wide and 2 feet deep (i.e. 6.3 cubic feet).

**Post-Application Directions:** Keep product in air-tight space for a minimum of seven (7) days. Odor dissipates when treated articles are aired.

**Retreatment:** Since moths are active all year, replenish air-tight containers, bags, and closets 2 times a year or when product has dissipated.

**WARNING:** Causes substantial but temporary eye injury. Harmful if swallowed or absorbed through skin. Causes eye, skin, and respiratory tract irritation. Wear safety glasses. Do not get in eyes or on clothing. Avoid contact with skin. Wash thoroughly with soap and water after handling. Remove contaminated clothing wash before reuse.

**NOTICE:** This product contains a chemical known to the State of California to cause cancer. This conclusion was based on scientific studies performed on laboratory animals.
