- Purpose** The purpose of your submission is to revise your labeling and CSF, under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA).
- CSF** Your CSF dated May 7, 2003, is acceptable. We have placed a copy in our files for this product. All other versions are obsolete.
- Label** The labeling submitted with the above letter, under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) is acceptable, provided you submit one (1) copy of final printed labeling, with the following changes, to us before you ship your product.
1. Your headings and subheadings do not follow a consistent format, thus making it difficult to follow your label's structure. One way to make the format clearer is to center the main headings (**DIRECTIONS FOR USE** and **PRECAUTIONARY STATEMENTS**) and left justify the subheadings (**Hazards to Humans and Domestic Animals** and **Physical or Chemical Hazard**). If you have an alternative method of accomplishing the same goal, you are free to use it.
 2. You need to make a greater distinction between selected subheadings and text. We would suggest bolding words like **Use Restrictions**, **Pre-Application Directions**, **Application Directions**, **Retreatment**, **Storage**, **Disposal**, **If empty**, and **If partly filled** to make these key words stand out from the text. Again, if you have an alternative method of accomplishing the same goal, you are free to use it.

A copy of the stamped label is enclosed for your records.

Existing stocks Stocks of existing labels may be used for eighteen (18) months.

Consequence for non-compliance If this condition is not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of this condition.

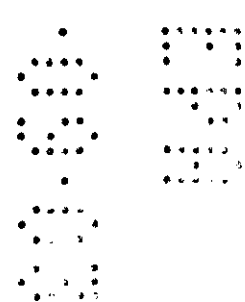

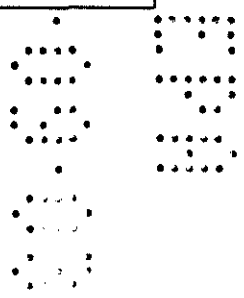

Directions for Use:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Use Restrictions: Each sachette bag can treat up to 6.3 cubic feet. Kills Clothes moths and Carpet beetles and their eggs and larvae in clean, airtight containers, such as chests, drawers, trunks, and garment bags. Do not use dry cleaning bags, garbage bags or other containers that allow vapors to escape into occupied rooms. This product can damage some plastics, use only in polyethylene or polypropylene containers.

Paradichlorobenzene should not be mixed or placed in contact with other moth preventive chemicals.

Pre-Application Directions: Before storing, dry clean, wash or brush articles to be protected.

Prevents moth infestation regardless of fabric type.

Application Directions: Calculate the volume to be treated in cubic feet by multiplying the height by the width, and depth of the space. One sachette can treat up to 6.3 cubic feet of storage space. Examples of the amount of product required for proper treatment are listed below:

- 2 sachette Average Garment Bag (12 cu. ft.)
- 3 sachette Large Trunk (15 cu. ft.)
- 8 sachette Small Storage Closet (50 cu. ft.) {24 oz. size only}

The proper treatment of larger volumes may require the use of additional containers of REEFER-GALLER® OLD FASHIONED Moth Sachettes (ENOZ® Moth Sachettes). To insure protection of your clothes, use the recommended amount of REEFER-GALLER® OLD FASHIONED Moth Sachettes (ENOZ Moth Sachettes).

Leave crystals in bags and place on top of articles in chests, drawers, trunks, garment bags and other closed storage receptacles. The vapors work downward killing all forms of moth life. Keep product in airtight space for a minimum of 7 days. When crystals have dissipated replace with new sachette bag. Odor quickly vanishes when articles are aired.

Retreatment: Since moths are active all year, replenish air-tight containers 2 times a year or when product has dissipated.
