For use as a preservative in manufacturing dry film paint generally use 0.4-3.0% in wet paint, for aqueous metal working, cutting, cooling and lubricating fluids and concentrates use 0.1-1.75%, for paper coatings use 0.5-2.85%, for plastics and plastic coatings use 0.17-3.75%, for cordage use 1.0-4.0%, for inks use 0.2-3.5%, for pigment dispersions\*, slurries\*, and gypsum slurries for wallboard (drywall and gypsum board)\* use 0.013-3%. For household, consumer, industrial, institutional, and janitorial products\* (such as liquid and solid air fresheners\*, dish detergents\*, laundry products\*, soaps and detergents\*, non-food contact surface cleaners\*, floor care products\*, bathroom cleaners\*, window cleaners\*, fabric care products\*, automotive care products\*, and furniture care products\*), use 0.013-0.1%.
