

DANGER

For use as a preservative in manufacturing dry film paint generally use 0.1-2.0% in wet paint, for aqueous metal working, cutting, cooling and lubricating fluids and concentrates use 0.05-0.5%, for paper coatings use 0.05-2.0%, for plastics and plastic coatings use 0.5-2.5%, for cordage use 0.5-2.5%, for inks use 0.05-3.0%. For wood preservation, use only in above-ground applications only at 0.5-3.0%. Fungitrol® 440S Fungicide can be used as a fungicide in non-medical, non food contact aqueous, solvent and non-solvent based systems such as natural and synthetic adhesives, caulks, patching compounds, sealants, grouts, latexes such as sbr/latex used in the manufacture of flooring adhesives or carpet backings and for use in cement-based products.
