2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
 - a) Remove claims in the directions for ~~☒~~Horses and Ponies~~☒~~, ~~☒~~Flying moths including Almond, Chocolate, Tobacco, Indian Meal and Angoumois Grain.~~☒~~ as they are unrelated to horse and pony treatment.
3. Submit three (3) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

INSTRUCTIONS: First brush animal to remove excess dirt and dust. Rub towelette against the natural lay of the hair. Carefully apply to face, around mouth, nose and eyes. Then apply to neck, middle and hind quarters, finishing legs last. Only a light application is required. Do not wet skin. After application, brush thoroughly to bring out a bright sheen on the coat. During the flea season, retreat every 3 – 4 weeks if necessary.
Do not use on foals or puppies under 12 weeks.
