NOTIFICATION

Dear Mr. Gebken:

W. F. Young, Inc. is submitting this notification for the product WFY0301 EPA Reg. No. 1543-15. This notification consists of a label change adopting the exact wording set forth in PR Notice 2001-6. It also includes a packaging change consistent with PR Notice 98-10 to add "Bag on Valve" packaging as an alternative package to the pump spray packaging. "Bag on Valve" packaging is made up of an aerosol valve with a bag welded to it. The bag is rolled, placed into a container and filled with the WFY0301 product (no change in formulation), while the Nitrogen propellant is between the bag and the wall of the container. In this way, a gas-tight separation of the product and the Nitrogen propellant is achieved. The product is dispensed at a similar rate to the normal pump spray. The advantage is that the container will still dispense the product when held upside down. The corresponding label change is made because the container is under 30 psi of pressure.

Also, reapply each time animal is washed or exposed to heavy rain for best results. After application, brush thoroughly to bring out bright sheen on the coat.

During the flea season retreat every 3 - 4 weeks if necessary. Kills fleas, ticks and lice on dogs and provides up to 28 days protection from reinfestation.
