

DIRECTIONS

Pour 3 1/2 gallons of Momar Insecti-Fog in a clean 55 gallon drum and fill the drum with #2 fuel oil. Fog only when winds do not exceed 8 to 10 miles per hour. Determine wind direction and allow fog to drift on desired area, staying upwind from the fog. Avoid fogging to any parked cars or other property because an oily film may be deposited. Use approximately 8 ounces of actual Malathion per acre or 4 gallons of the diluted product per acre to kill adult mosquitoes and gnats. Repeat treatment as necessary.

FLIES

Envelop in a fine fog or mist. Use fog for killing flies by fogging critical areas such as stable, barns, rubbish piles, etc. Do not use in dairy barns or on livestock. Repeat treatment as necessary.

MOSQUITOES AND GNATS

Envelop total area to be treated with a coarse fog or fine mist allowing it to drift in uncultivated fields, into shrubbery that would not be injured by the oily fog. Also fog roadsides and wastelands where edible crops would not be contaminated or valuable ornamentals and shade trees would not be injured. Pay particular attention to all zones of stagnation. Repeat treatment as necessary.

MOSQUITO LARVAE IN STANDING WATER

Apply at rate of 1/2 pound actual Malathion or 4 gallons of the diluted product per acre. Repeat treatment as necessary.
