## Home Gardens

To control the insection the crops listed below, apply the dust uniformly and thoroughly to upper and lower surfaces of the foliage, but do not apply excessive amounts. Begin applications when insects or their damage first appears. Repeat as necessary, generally at weekly intervals. May be applied on day of harvest unless otherwise stated.

Beans: Mexican Bean Beetle, Bean Leaf Beetle, Cuoumber Beetle, Japanese Beetle Adults. L'éafhoppers, Flea Beetles, and Corn Earworm.

Corn (Sweet): Corn Earworms, Fall Armywerms, Flea Beetles, Japanese Beetle Adults, Sap Beetles, and Leafhoppers. For larvae in the whorls (Fall Armyworms) and foliage feeders, apply to entire plant before tasseling. For insects attacking silks and ears apply when silks first appear and repeat at 2 to 3 day intervals until silks become dry. Three or more applications may be required. Proper timing and uniformly thorough coverage are essential. Application of this product to the tassel region of corn during the pollen-shed period will seriously reduce bee populations.

Cucumbers, Melons, and Squash: Pickle Worm, Melonworm, Cucumber Beetles, Squash Bug, and Leafhopper. Avoid excessive applications. Do not use on watermelons.

Potatoes, Tomatoes, Eggplant, and Peppers: Colorado Potato Beetle, Leafhoppers, Mea Beetle, Fall Armyworm, Tomato Fruit Worm, Tomato Hornworm, Blister Beetle, and Tarnished Plant Bug.

Cabbage, Broccoli, and Cauliflewer: Harlequin Bug, Leafhoppers, Imperted Gabbage Werm, and Corn Earworm. Do not apply within 3 days of harvest.

Garden Beets, Lettuce, Radishes, Spinach, Turnips, and Carrots: Fiea Beetles, Leafhoppers, Harlequin Bug, Fall Armyworm, Corn Earworm, Spittlebugs, and Tarnished Plant Bug.

Do not apply to garden beets, head lettuce, radishes, and turnips within 3 days of harvest. Do not apply to leaf lettuce and spinach or to garden beets and turnips, if tops are to be used for food or feed, within 14 days of harvest.

Blackeyed Peas: Cowpeas Curculio and Lygus Bug.

Okra: Japanese Beetle Adults and Blister Beetles.

Strawberries: Meadow Spittlebug, Strawberry Leaf Roller, and Swawberry Weevil. De not apply within I day of harvest.

Some injury to the crops named above may occur if treatments are made when foliage is wet or during periods of high humidity for two or three days fellowing an application.

# CAUTION

May kill honeybees in substantial numbers. This product is highly texic to bees exposed to direct treatment or residues on crops. Do not use when the value of bees as pollinators is more important than insect control. Before applying warn beekeepers to locate hives beyond bee flight range until one week after application or to take other effective precautions.
