

DIRECTIONS FOR USE

PREPLANTING SOIL APPLICATION ONLY: Keep all persons and animals out of treated areas for 48 hours after application. Soil Temperatures MUST be at least 50 degrees F. for material to be effective.

TOBACCO: To control Southern Motain Wireworm and other wireworms, uniformly broadcast 50 to 75 pounds (2 to 3 pounds of actual parathion) per acre and immediately incorporate into the top 6 to 9 inches of soil from 1 to 3 weeks prior to transplanting. Use higher dosage where wireworms have been a problem. Treatment should be made annually on land to be planted to tobacco.

POTATOES: To control Southern Potato Wireworm and other wireworms, uniformly broadcast 75 to 100 pounds (3 to 4 pounds of actual parathion) per acre prior planting and immediately incorporate into the top 6 to 9 inches of soil. Use higher dosage where wireworms have been a problem. Treatment should be made annually on land to be planted to potatoes.

BEANS, CABBAGE, CARROTS, CAULIFLOWER, LETTUCE (Head) and SCYBEANS:

To control wireworms uniformly broadcast 75 to 100 pounds (3)

to 4 pounds actual parathion) per acre prior planting and immediately incorporate into the top 4 to 6 inches of soil.





IMPORTANT! Before removing gloves, wash them with soap and water. Always wash hands, face and arms with soap and water before smoking eating or drinking.

POISON SIGNS (Symptoms)

Parathion is a very dangerous poison. It rapidly enters the body on contact with all skin surfaces and eyes. Clothing contaminated with this material must be removed immediately. Exposed persons must receive prompt medical treatment or they may die.

Some of the signs and symptoms of poisoning are: Headache, nausea, vomiting, cramps, weakness, blurred vision, pin-point pupils, tightness in chest, labored breathing, nervousness, sweating, watering of eyes, drooling or frothing of mouth and nose, muscle spasms and coma.

FIRST AID TREATMENT

Call a doctor (physician), clinic or hospital immediately. Explain that the victim has been exposed to parathion and describe his condition.

If breathing has stopped, start artificial respiration immediately and maintain until doctor sees victim. If swallowed and victim is awake (conscious) make him vomit quickly. Induce vomiting by sticking finger down throat or by giving soapy or strong salty water to drink. Repeat until vomit is clear. Never give anything by mouth to an unconscious person. Have victim 96.0% lie down and keep quiet. See doctor immediately.

> In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. See doctor immediately.

NOTE TO PHYSICIAN

ANTIDOTE: Administer atropine sulfate in large doses, TWO to FOUR mg. intravenously or intramuscularly as soon as cyanosis is overcome. Repeat at 5 to 10 minute intervals until signs of atropinization appear. 2 PAM chloride is also antidotal and may be administered in conjunction with atropine. DO NOT GIVE MORPHINE OR TRANQUILIZERS Parathion is a strong cholinesterase inhibitor affecting the central and peripheral nervous systems and producing cardiac and respiratory depression. At first sign of pulmonary edma, the patient should be given supplemental oxygen and treated symptomatically. Continued absorption of the poison may occur and fatal relapses have been reported after initial improvement, VERY CLOSE SUPERVISION OF THE PATIENT I' INDICATED FOR AT LEAST 48 HOURS
