

Billbugs, Japanese Beetly Larvae, European Chafer Grubs, and Southern Chafer Grubs.

Apply 2.5 pounds per 1000 square feet lawn (4 ounces per 100 square feet). Water grass thoroughly after application. For grub control, make application any time between late July and early October.
