quarters of can is used, re-fill from a fresh can. Coverage rate for Semi-Transparent Stain will vary widely, depending on the porosity and texture of the wood. A second coat can be applied, if necessary, after a 24-hour dry. Colors can be modified by the addition of up to 1/4 pint of Universal Tinting Colors per gallon.
