For control of decay and termites in all wood products such as timbers, posts, millwork, lumber and wooden buildings.

Protects against mildew, mold and wood borers.

Controls chicken mites, lice and ticks.

DIRECTIONS FOR USE

Wood Preservative: Warlasco Wood Preservative should be applied to affect maximum penetration and absorption into the wood. Complete immersion of the wood in Warlasco Wood Preservative (open tank treatment) for five minutes per inch of thickness. For existing structures a heavy brush application is recommended. Apply two coats to parts of existing structures coming in contact with ground.

Fence posts, poles, foundation timbers and heavy wooden members should be free of bark, dry and well-seasoned and immersed in the product for a period of 12 to 48 hours.

Termite Control: Clean out all debris and loose wood near infested structure. Spray ground under structure (2 gallons Warlasco Solution per 5 cubic feet) Where possible, eliminate all wood to earth contact and replace with Warlasco Wood Preservative treated wood. It is advisable to dig a 12"-18" trench around all foundations and apply 1 gallon Warlasco Pentachlorophenol per 2.5 lineal feet and 1 gallon per lineal foot of trench deeper than 18". Trenches around foundations may be 30" deep but should not be below the top of the footing.

Shrubs and trees should be protected from treated soil with heavy kraft paper.

Treating Poultry Houses for Mites and Ticks: Spraying is recommended for these structures in order to penetrate all cracks. If applied with brush, apply two heavy coats. After treatment, provide thorough ventilation and keep building unused for 48 hours. New fresh nesting material should be provided after treatment of the house.
