This Household Fly Spray contains pyrethrins and piperonyl butoxide which are non-toxic to humans and pets. It is a highly effective insecticide for rapid control of flies, mosquitoes, roaches, silverfish, bed bugs, ants, and clothes moths found in homes and other buildings. It can be used around food, food products, and utensils, according to directions, without danger of contamination but should not be applied directly to uncovered food or foodstuffs.

TO OPERATE: Remove protective cap, hold dispenser upright and press button to release mist. Always hold dispenser at least three feet from any surface.
FOR FLYING INSECTS SUCH AS HOUSEFLIES & MOSQUITOES: Shut doors and windows and spray room at the rate of three to five seconds per 1000 cubic feet. Keep room closed for at least fifteen minutes after spraying.

TO KILL ROACHES & SILVERFISH: Spray directly into cracks, crevices and other secluded places. Direct spray at insects when they appear. Average size kitchen requires 65 to 75 seconds of spraying.

TO KILL BED BUGS: Dismantle bed and spray bedding, folds, seams, tufts, and other parts of mattress. Hold dispenser at least three feet from light colored surfaces.

TO KILL ANTS: Spray directly at insects and ant trails and other places where ants congregate.

TO KILL CLOTHES MOTHS: First clean and brush garments thoroughly. Spray the entire garment, paying particular attention to all folds, seams and lapels. Spray closets, using 30 to 40 second exposure. Repeat every 30 days.

CAUTION

Do not spray plastics or asphalt tile direct. Use the product as a space spray in food processing plants only when plant is not in operation. Foods should be removed or covered during treatment. All food processing surfaces should be covered or thoroughly cleaned before using. Remove bird cages and fish bowls from rooms being sprayed. To avoid staining hold spray 3 ft. from all objects. Do not puncture container or dispose of in fire. Container should not be placed where temperature exceeds 120° Fahrenheit.
