

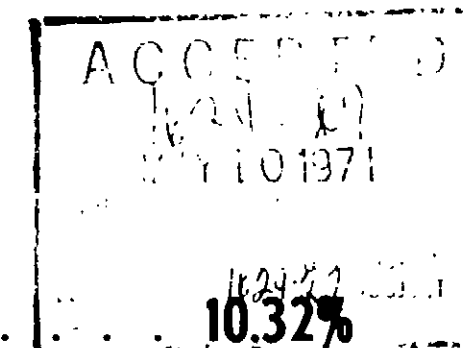

Active Ingredients:

ANHYDROUS SODIUM METABORATE ($\text{Na}_2\text{B}_2\text{O}_4$)	10.32%
SODIUM CHLORATE (NaClO_3)	18.76%
ANHYDROUS SODIUM SALT OF 2, 4-DICHLOROPHENOXYACETIC ACID	0.21%
(2, 4-Dichlorophenoxyacetic Acid Equivalent)	0.19%
INERT INGREDIENTS	70.71%

CAUTION

APPLICATION

Apply as a contact spray thoroughly wetting all parts of the plants, particularly the growing tips. Apply $\frac{1}{2}$ - 1 gallon of solution per 200 to 300 square feet when the plants are young and tender (1 to 4 inches high).
