

KEEP OUT OF REACH OF CHILDREN

ANTIDOTE-Give a tablespoon of salt and glass of werm water and repeat until vomit fluia is clear, then 2 tablespoons of epsom salts or milk of magnesia in water and plenty of milk and water. Have victim lie down and keep quiet. Cell physician immediately.
