Bromacil (5-bromo-3-sec-butyl-6-methyluracil) 0.3%

INERT INGREDIENTS 82.7%

**USE FOR CONTROLLING VEGETATION ON
RAILROAD RIGHTS-OF-WAY OR SIMILAR
NON-CROPLAND AREAS**

HB 107-3 weed and grass killer should be applied without further dilution. Apply at the rate of 100 to 200 gallons per acre (Approximately 1/4 to 1/2 gallon per 100 sq. feet) using a pressure sprayer. For control of perennial grasses and perennial broad-leaved weeds, the heavier rates are suggested. For control of annual weeds, apply HB 107-3 as a contact spray when plants are young, thoroughly wetting all parts of the plant, particularly the growing tips. For control of perennial grasses, such as Johnson grass, late summer or fall applications are recommended.

Do not apply HB 107-3 sprays on desirable plants or over the root area of desirable trees or shrubs. Avoid spray drift to susceptible plants.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

STORAGE AND DISPOSAL

1. PROHIBITIONS

Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited.

2. PESTICIDE DISPOSAL

Pesticide spray mixture or residue that cannot be used or chemically processed should be disposed of according to procedures approved by Federal, State or Local disposal authorities.

3. GENERAL
