KILLS . . . Flies, Mosquitoes, Gnats, Roaches, Waterbugs, Silverfish, Ants, Fleas, Ticks, Hide Beetles, Mites, Spiders, Centipedes, Millipedes, Flour Beetles, Grain Weevils, Flour Moths and Grain Moths.

FOR RESIDUAL AND CONTACT SPRAYING

KNOX RESIDUAL INSECTICIDE B knocks down and kills many flying and crawling insects as either a residual insecticide or as a contact spray. The multi-mixture of Lindane combined with Methoxychlor gives extra effectiveness, faster knockdown with high kills.

FLIES, MOSQUITOES, AND GNATS: For residual control wet thoroughly all areas where these insects alight or crawl. Be sure to treat areas around door sills and window frames where the pests may enter the premises. Repeat application as often as necessary to maintain an effective residual deposit of KNOX RESIDUAL INSECTICIDE B.

ROACHES, WATERBUGS AND SILVERFISH: Thoroughly wet infested cracks and hiding places, wetting the surfaces frequented by these pests. Repeat application as often as necessary to maintain an effective residual deposit of KNOX RESIDUAL INSECTICIDE B. **ANTS:** Spray ants, ant trails, areas around door sills and window frames where the pests enter the premises. Repeat as often as necessary.

FLEAS AND TICKS: Treat infested areas around baseboards, localized areas of floors; do not apply to areas frequented by children and do not allow them in treated areas until dry.

HIDE BEETLES: For residual protection sweep or clean dirt and dust from surface locations before wet spraying with KNOX RESIDUAL INSECTICIDE B. Use at rate of one gallon per 1,000 square feet of surface, being certain to thoroughly wet infested cracks and hiding places of the beetles. Repeat as often as necessary.

SPIDERS, HOUSE-CENTIPEDES, AND MILLIPEDES: Thoroughly spray and repeat spraying of the infested area, working KNOX RESIDUAL INSECTICIDE B into cracks and other hiding places. Direct KNOX RESIDUAL INSECTICIDE B to hit the pests wherever possible. Repeat applications.

FLOUR BEETLES, GRAIN BEETLES, GRAIN WEEVILS, FLOUR MOTHS AND GRAIN MOTHS: For controlling the exposed stages of these insects in Railroad Box Cars prior to lining with paper and loading, spray KNOX RESIDUAL INSECTICIDE B to side and end box car liners, floor, cracks and hiding places. Use at the rate of one to one and a half gallons per box car depending on how severe car is infested.

FOR OUTDOOR USE: KNOX RESIDUAL INSECTICIDE B temporarily repels many bothersome insect pests around outside of buildings. Spray outside walls, grounds, sidewalks, mats and window screens. Repeat application as often as necessary.

External — Wash with soap and water.

Internal — Drink emetic of mustard, call physician.
