

DIRECTIONS FOR USE



ROACHES: Don't close up room. Never spray into air. Lift protective cap. Press trigger. Hold container so that spray is directed at the surface to be sprayed at a distance of 6 inches to 1 foot. All spraying to be on a spot basis. Spray until surface is wet usually at the rate of 1 to 2 feet per second. Spray directly into infested cracks, crevices, behind sinks, stove, refrigerator. Make sure pilot light is off on stove or refrigerator. Let dry. This thorough application often is effective for considerable periods of time (up to 2 weeks). Reapply if reinfestation due to migration or other causes occurs. The residual coating left by the above treatment is not easily swept away. Nevertheless thorough housecleaning with soap and water removes film, so reapply after such cleaning.

ANTS: As for ROACHES: on ant trails if possible and directly into ant nests: on areas around door sills, window frames, water pipes, heat ducts, electrical outlets and baseboards. Repeat as necessary to maintain effective control. When used outdoors, do not spray vegetation.

WATERBUGS - SILVERFISH, SPIDERS. Spray directly on insects if possible or as for ROACHES. Also on exposed pipes.

BROWN DOG TICKS IN PREMISES:
As for ROACHES, also repeated treatments as necessary depending on source and intensity of infestation around baseboards, window and door frames, localized areas of floors and floor coverings, wall cracks and sleeping quarters of pets. Replace fresh bedding in animal quarters following treatment. Do not treat pets or other animals.
