ROACHES:

Dro Professional Brand Kills roaches by contact and when they crawl over surfaces which have been treated with Dro. Spray or brush on a spot basis only, directly into infested cracks, crevices, tunnels, legs of tables. Apply locally where insects hide, run or rest.
