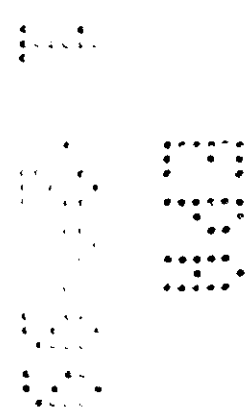

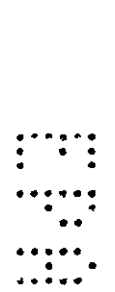

Keeps pets away from trees, shrubs, garbage cans/bags and other "forbidden areas". Reduces the frequency of defecation and urination by dogs on lawns and flower gardens. Reduces frequency of digging by cats in flower gardens.

**NOTE:** This product is not likely to break the established urination patterns of dogs unless it is used as a training aid.
