Purpose The purpose of your submission is to amend the label of your product in accordance with PR Notices 2001-1 (First Aid) and 2001-6 (Disposal Statements).

Review of label The labeling submitted with the above letter, under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) is acceptable, provided you submit one (1) copy of final printed labeling to us, with the following changes, before you ship your product. A copy of the stamped label is enclosed for your records.

1. Revise your homeowner "STORAGE AND DISPOSAL" text as follows:

STORAGE AND DISPOSAL

Storage: Store only in the original container in a cool, dry place inaccessible to children and pets.

Disposal:

- **Empty containers:** Do not reuse this container. Place in trash or offer for recycling, if available.
 - **Partly filled containers:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Do not place unused product down any indoor or outdoor drain.
2. At the top of your "Back/side" panel, change "10 days" to "24 hours" to be consistent with other label text, "Will repel dogs and cats up to 24 hours when applied daily."
 3. Because this is an outdoor product, in your "USE RESTRICTIONS", delete "For both indoor and outdoor situations" and "furniture, carpet".

- Existing stocks** Stocks of existing labels may be used for eighteen (18) months.
- Consequence for non-compliance** If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of this condition.

OUTDOOR USE:

Keeps pets away from trees, shrubs, garbage cans/bags and other "forbidden areas". Reduces the frequency of defecation and urination by dogs on lawns and flower gardens. Reduces the frequency of digging by cats in flower gardens.

NOTE: This product is not likely to break the established urination patterns of dogs unless it is used as a training aid.

PRE-TREATMENT DIRECTIONS:

Stray animals are frequently attracted to areas where pets have soiled with feces or urine. To discourage repeat visits, remove any droppings and clean with water.

APPLICATION DIRECTIONS:

Do not apply directly to foliage of shrubs or to ornamental, soft-bodied plants. Do not apply to food or feed crops. Using gloves, lightly sprinkle granules directly from the container or use a spreader at the rate of 1 lb. per 250 sq. ft. Apply as a border to the item to be protected.

RE-TREATMENT DIRECTIONS:

Repeat daily, or as necessary, until undesirable habit is broken.

STORAGE AND DISPOSAL

STORAGE: Store unused material in original container only, in a locked storage area out of reach of children and animals. Do not contaminate water, food or feed by storage or disposal.
