Label Comments:

- On the front panel, under the product name, add the following text: "*Excludes Carpenter, Fire, Harvester, and Pharaoh Ants." Add an asterisk to ALL subsequent references to ants so they read, "...ants*..." The above listed types of ants require additional efficacy data.
- Under the Optional Marketing Statements, the phrase "Guaranteed to Work" MUST be used with the phrase "Or Your Money Back," or it must be deleted. An unqualified guarantee is not acceptable, as it contradicts the NOTICE paragraph on page 3, which states "...seller makes no warranty..."
- Change the phrase "Active Ingredients" (plural) to "Active Ingredient" (singular).
- Under the Directions for Use section, modify the first sentence of the fourth paragraph so it reads, "Grant's Ant Control System kills ants (excluding carpenter, fire, harvester, and pharaoh ants) now...and helps prevent their return."
- On page 3, the Warranty section contradicts the preceding NOTICE paragraph, which states "...seller makes no warranty..." Either delete the Warranty section or revise the text so it reads, "Guaranteed to work when used as directed, or your money back."



To control grease eating and sweet eating house ants in and around homes

Outdoors: Surround house with states (bait stations) (ant baits), six to eight feet apart on all sides. Place stakes (bait stations) (ant baits) at both sides of all outside doors and all corners. Larger homes or buildings may require more than one package.

Indoors: Place stakes (bait stations) (ant baits), hole side up, under sinks, on counters, behind appliances and along ant trails.

GRANT'S starts to work immediately. Some ants die in hours. Larger colonies may take a week or longer. GRANT'S works until ants have taken away all the bait. For continuing protection, replace stakes (bait stations) (ant baits) every 3 to 6 months, or sooner if stakes (bait stations) (ant baits) are empty.
