

The following requirements or revisions apply to the label which was accepted with this registration notice:

1. The registration number which has been assigned to this product must appear on the label as EPA Registration No. 1677-94.
2. In the precautionary statement paragraph change "Wear goggles or face shield when handling" to the revised wording of "Wear safety glasses or goggles when handling."
3. The labels which will be used for this product in channels of trade must reflect these revisions.
4. Five copies of the finished printed labels, as identified in the A-79 enclosure, must be submitted to the Agency before the product is released for shipment to comply with PR Notice 82-2 of June 13, 1982.
5. The finished printed labels must comply with the general labeling requirements of Section 162.10 of Title 40 of the Code of Federal Regulations. If the label does not satisfy these requirements, it will be rejected.

L-A-W NP

L-A-W NP is a non-abrasive, liquid cleaner that quickly and easily dissolves lime scale, rust, and other hard water deposits. It leaves tiles, sinks, and fixtures shiny clean without scrubbing or scratching.

DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Recommended for use on hard, nonporous, inanimate surfaces.

GENERAL CLEANING: Mix with equal parts of water. Wearing household gloves apply with sponge or cloth. Rinse with water.

TO DISINFECT: Remove heavy deposits and gross soil. Mix with equal parts of water and apply as above. Thoroughly wet entire surface and let stand 2 minutes. Rinse with water.

For heavy mineral deposits and stains use full strength. Rinse well.

NOTE: L-A-W NP may etch some ceramic tiles, tubs, and sinks. If in doubt, test a small area first. Avoid contact with wood or clothing. DO NOT use on marble, polished aluminum, metallic glazed surfaces, terrazzo or colored grout.

L-A-W NP is ideal for cleaning fiberglass surfaces, sinks, toilet bowls, tubs, shower doors, tile, chromium fixtures, stainless steel, and glass.

OTHER USES: Use L-A-W NP full strength to clean pots, pans, tea kettles, humidifiers, vaporizers. Rinse thoroughly after use. To clean dishwasher or washing machine, run empty machine to main wash without detergent. Stop machine, add one cup L-A-W NP and complete cycle. Repeat if necessary.

PRECAUTIONARY STATEMENT: Hazard to humans and domestic animals

Eye Contact: Flush freely with cool running water. Remove contact lenses, if applicable, then continue flushing with water for 15 minutes. Get medical attention.

Skin Contact: Flush thoroughly with cool running water.

If Swallowed: DO NOT induce vomiting. Rinse mouth; then drink one or two large glasses of water or milk. DO NOT give carbonates or bicarbonates.

STORAGE AND DISPOSAL: Store in cool dry place. In cases of spill, flood with water. Do not reuse empty container. Rinse thoroughly with water and discard in trash.
