DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Using the appropriate Ecolab dispenser, inject **AdvaCare** as a sour and sanitizer at a rate of 3 ounces per 100 pounds dry laundry in the final rinse water. Treat the laundry for a minimum of 5 minutes at 90°F.

STORAGE AND DISPOSAL: DO NOT CONTAMINATE WATER, FOOD OR FEED BY STORAGE OR DISPOSAL

STORAGE: Product should be kept cool and in vented container to avoid any explosion hazard. PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous.
