

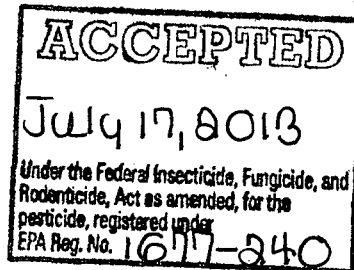

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

The Hydris Dispenser is designed to use electricity to convert water and the Hydris Mineral Activator Tablet into an alkaline bleach solution. This conversion is accomplished using a three-chambered electrolytic cell. During normal operation, the Hydris Dispenser will refill a day tank automatically and only require operator input when an alarm indicates that more Hydris Mineral Activator Tablets are needed in the brine tank.

1. Insert Hydris Mineral Activator Tablet into slot on the Hydris Dispenser indicated by "Insert Tablet Here."
 2. Close front panel.
