This formulation developed for certification of balled and bur'lapped and potted plants, Zoysia Turf and certain soil treatments for the use in a USDA JAPANESE BEETLE QUARANTINE PROGRAM.

Active ingredients:

*Ethylene Dibromide	20%
**Chlordane (Technical)	10%
Inert ingredients:	70%

All of above percentages are by weight 100%

**Equivalent to 6% "octachloro-4, 7-methanotetrahydroindane" and 4% of related compounds.

DOSAGE for certification of balled and burlapped and potted plants is 2 cubic centimeters of this concentrated materials to 1 gallon of water, or approximately 1 gallon of this concentrated material added to water will make approximately 1890 gallons of dipping solution, for certification under regulations.

DOSAGE for the treatment of Zoysia Turf and surface and other treatments of soil, consult your local authorized inspector.

This product is only used by Nurserymen under the supervision of USDA inspector.

Agitate before withdrawing from container.
