DIRECTIONS:

For Roadsides, Highways, Cemeteries, Parks, Fence rows and turf use.

WEED CONTROL IN SMALL AREAS: Use 1 sup of Weed-Away in 3 gallons of water and wet the undesirable weeds thoroughly for best results.

SPOT IREATMENT: For Knapsack application of Weed-Away for spot treatment of such weeds as this left dandelions, and similar hard-to-kill weeds, use I pint of Weed-Away in three gallons of water or 3 gallons of Weed-Away per acre in sufficient water to give coverage for most extensive areas. Spray to wet weeds thoroughly, Repeat the treatment as required.

TURF WEED CONTROL: For lawns, pastures and other turf areas, use 1 to 1 and 1/2 gallons of Weed-Away in sufficient water per acre. Dilute 1/2 cup of Weed-Away in 3 gallons of water and apply to 1000 square feet. Use higher rate for hard-to-kill weeds such as white top canada thistles. Apply when foliage is growing rapidly in late spring or early summer. Wet all foliage thoroughly. Repeat the treatment as required.

NOTE: In weed control in grasses, repeat treatment may be needed for less susceptible weeds. White clover and other legumes may be temporarily injured or killed. In some areas, bent buffalo, carpet and St. Augustine grasses may also be injured by the treatment. GENERAL WEED CONTROL: In vacant lots on

areas, bent buffalo, carpet and St. Augustine grasses may also be injured by the treatment. GENERAL WEED CONTROL: In vacant lots on roadsides and along fence rows, use enough spray to wet all foliage. One cup of Weed-Away in 3 gallons of vater will control most young weeds, however 1 and 1/2 cups may be necessary for more resistant weeds. Deep rooted perennial weeds such as bindweed, capada thistles, Bondelions and pigweed may require repeated applications as new growth appears. Application should be made when plants are actively growing in late spring or early summer and foliage is fully expanded.
