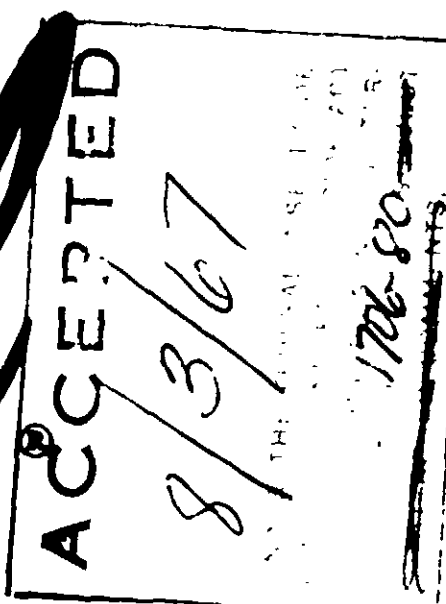

## WEED KILLER 400 CONCENTRATE

Petroleum oil .....	61.76%
2,4-Dichlorophenoxyacetic acid isooctyl ester* .....	10.29%
Bromacil (5-bromo-3-sec-butyl-6-methyluracil) .....	9.14%
Pentachlorophenol .....	7.19%
Other Chlorophenols .....	0.86%

**DIRECTIONS:** This product should not be applied directly but should be diluted by adding 4 gallons of NalKil 400 Concentrate to 39.5 gallons of a phytotoxic oil vehicle and mix thoroughly. To control most weeds and grasses on non-cropland areas such as railroad rights-of-way and industrial sites for an extended time, apply 43.5 gallons per acre of diluted product after the most predominant weeds have emerged. After dilution no further agitation is required. The diluted product should be applied with railroad on-track, truck mounted or other standard spraying equipment. For treating small areas, a tank-type hand sprayer or sprinkling can may be used.

**NOTE:** Users should consult State Agricultural Experimental Station or Extension Service Weed Specialists for recommendations as to use of NalKil 400 Concentrate in their particular area or write to Nalco.

**IMPORTANT:** Do not apply directly to, or otherwise permit NalKil 400 Concentrate or its diluted form to contact susceptible plants as this product may injure cotton, beans, peas, grapes, flowers, fruit trees, ornamentals or other desirable plants. Avoid spray drift to such susceptible plants (coarse sprays are less likely to drift). Vapors from this product may injure susceptible plants in the immediate vicinity. Thoroughly clean spray equipment with a suitable chemical cleaner before using for other purposes (or do not use the same equipment for other purposes). Do not store near fertilizers, seeds, insecticides or fungicides. Do not re-use this container.

NalKil 400 Concentrate is toxic to fish. Do not contaminate any body of water.

**WARNING: HARMFUL IF SWALLOWED OR ABSORBED THROUGH SKIN. CAUSES SKIN IRRITATION.** Do not get in eyes, on skin or on clothing. Avoid prolonged or repeated breathing of vapor. Wash thoroughly after handling. In case of contact, flush with large amounts of water; for eyes, get medical attention. Remove and wash contaminated clothing before re-use.
