

DIRECTIONS: To control most weeds and grasses for extended periods on non-cropland areas such as industrial plant sites, parking lots, loading ramps and around storage buildings and the like apply 1.5 to 7 gallons per 1000 square feet of NalKil 2701 Liquid with Endrift after the most predominant weeds have emerged. No agitation is required. NalKil 2701 Liquid with Endrift can be applied with standard spray equipment. For treating small areas, a tank type hand sprayer or sprinkling can may be used.

NOTE: Users should consult State Agricultural Experiment Stations or Extension Service Weed Specialists for recommendations as to use of NalKil 2701 Liquid with Endrift in their particular area, or write to Nalco.

IMPORTANT Do not apply directly to, or otherwise permit NalKil 2701 Liquid with Endrift to contact susceptible plants as this product may injure cotton, beans, peas, grapes, flowers, fruit trees, ornamentals, or other desirable plants. Avoid spray drift to such susceptible plants (coarse sprays are less likely to drift). Vapors from this product may injure susceptible plants in the immediate vicinity. Do not apply to areas underlaid by roots of desirable trees and shrubs. Thoroughly clean spray equipment with a suitable chemical cleaner before using for other purposes (or do not use same equipment for other purposes). Do not store near fertilizers, seeds, insecticides or fungicides. Do not reuse this container.

NalKil 2701 Liquid with Endrift is toxic to fish and wildlife. Birds and other wildlife in treated areas may be killed. Keep out of lakes, streams, or ponds. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from areas treated. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.
