

PIRECTIONS: To control most weeds and grasses on non-cropland areas such as railroad rights-of-way and industrial sites for an extended time, apply 43.5 gallons per acre of undiluted NalKil 400 after the most predominant weeds have emerged. No agitation is required. NalKil 400 should Le applied with railroad on track, truck mounted, or other standard spraying equipment. For treating small areas, a tank-type hand sprayer or sprinkling can may be used.

NOTE: Users should consult State Agricultural Experiment Stations or Extension Service Weed Specialists for recommendations as to use of NalKil 400 Liquid with Endrift in their perticular area or write Nalco.

IMPORTANT: Do not apply directly to, or otherwise permit NalKil 400 Liquid with Endrift to contact desirable, woody or herbaceous plants or areas where their roots may extend. Avoid spray drift to such plants (coarse sprays are less likely to drift). Vapors from this product may injure susceptible plants in the immediate vicinity. Thoroughly clean spray equipment with a suitable chemical cleaner before using for other purposes (or do not use same equipment for other purposes). Do not store near fertilizers, seeds, insecticides or fungicides. Do not contaminate water used for irrigation or domestic purposes. Do not reuse drum. Return to drum reconditioner or destroy when empty by perforating or crushing followed by burial in a safe place away from water supplies.

This product is toxic to fish and wildlife. Birds and other wildlife in treated areas may be killed. Keep out of lakes, streams, ponds or public water. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from treated areas. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.
