STATEMENT OF PRACTICAL TREATMENT: If swallowed, feed bread soaked in milk, followed by olive oil or cooking oil. Seek medical attention immediately. In case of skin contact, brush off excess chemical and flush skin with cold water for at least 15 minutes. If irritation develops, seek medical attention. In case of eye contact, flush eyes with cold water for at least 15 minutes. Seek medical attention promptly.

PRECAUTIONARY STATEMENTS. HAZARDS TO HUMANS AND DOMESTIC ANIMALS. DANGER. CORROSIVE. Causes eye and skin damage. May be fatal if swallowed. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield and rubber gloves when handling. Irritating to nose and throat. Avoid breathing dust. Remove and wash contaminated clothing before reuse.

ENVIRONMENTAL HAZARDS. This product is toxic to fish. Do not discharge into lakes, streams, ponds or public water unless in accordance with a NPDES permit. For guidance, contact your regional office of EPA.

PHYSICAL AND CHEMICAL HAZARDS. Strong oxidizing agent. Mix only with water. Use clean, dry utensils and equipment. Do not add this product to any dispensing device containing remnants of any other product. Such use may cause a violent reaction leading to fire and explosion. Contamination with moisture, organic matter or other chemicals may start a chemical reaction with generation of heat, hazardous gases and possible fire and explosion. In case of contamination or decomposition, do not reseal container. If possible, isolate container in open air or well ventilated area. If necessary, flood with large volumes of water.

STORAGE AND DISPOSAL: Keep product dry in tightly closed original container when not in use. Store in a cool, dry well ventilated area away from heat, open flames, organic chemicals and sunlight.... DO NOT REUSE EMPTY CONTAINER. Rinse empty container thoroughly with water and discard in trash.

DIRECTIONS FOR USE. It is a violation of Federal law to use this product in a manner inconsistent with its labeling. When used as directed, this product is effective as a pool water disinfecting agent.

The filter system should be backwashed or properly cleaned and the pH adjusted between 7.4 and 7.6. It is necessary to initially stabilize pools with 20-30 ppm cyanuric acid to effectively maintain the desired concentration of stabilizer. Thereafter, it is recommended that 40-50 ppm cyanuric acid be maintained in the pool water to nullify the dissipation effect of sunlight on chlorine. When using this product, both chlorine and cyanuric acid are being added to the water.

A free available chlorine residual of 1.0 to 2.0 ppm must first be established in the pH adjusted and conditioned pool. It is recommended that this be done with a granular product such as NOK-OUT or GRANULAR CONCENTRATE, following the directions on their labels.

Maintain a free chlorine residual of 1.0 to 2.0 ppm by placing one (1) Skimmer Stick per 5,000 gallons of pool water into the skimmer or automatic feeding device per week. Usage may vary depending upon bather load and environmental conditions. Do not add other chemicals through the skimmer when using this product in the skimmer.

The regular use of a test kit will determine if further adjustments may be necessary to maintain the recommended level of free available chlorine in the pool water. Do not swim in the water if the chlorine residual is greater than 3.0 ppm.
