STATEMENT OF PRACTICAL TREATMENT. If swallowed, drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person. Call a physician immediately. In case of skin contact, wash thoroughly with soap and water. In case of eye contact, flush eyes copiously with water for at least 15 minutes. Seek medical attention promptly.

PRECAUTIONARY STATEMENTS. HAZARDS TO HUMANS AND DOMESTIC ANIMALS. DANGER. CORROSIVE. Causes irreversible eye damage and skin irritation. Do not get in eyes, on skin, or on clothing. In case of contamination or decomposition, do not reseal container. If possible, isolate container in open air or well ventilated area. If necessary, flood with large volumes of water.

Dihalo Granular is to be used only for repackaging or formulating as a disinfectant, sanitizer, bactericide, fungicide, and slimicide. Registration by the Environmental Protection Agency is required before the new product can be lawfully distributed in interstate commerce.

STORAGE AND DISPOSAL. Keep product dry in closed container when not in use. Store in a cool, dry, well ventilated area away from heat, open flames and organic chemicals. Do not reuse empty container. Place empty container in trash collection or dispose in approved landfill area or burn in a safe place.
