### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

When used as directed, AQUABROME II TABLETS are effective as a swimming pool water sanitizer and disinfectant. The filtration system should be in proper working order, the pH adjusted between 7.2 and 7.6, the total alkalinity maintained between 100 and 150 ppm, and the calcium hardness maintained between 150 to 300 ppm.

A bromine or chlorine residual of 1.0 to 2.0 ppm must first be established in the pH adjusted pool. If this is accomplished with a granular hypochlorite product such as NOK-OUT or FAST SHOCK, follow use directions on that product's label. If the residual is established with AQUABROME II TABLETS in an Aquabrome brominator, use the brominator at the highest feed rate following manufacturer's recommendations. When the bromine residual reaches 1.0 to 2.0 ppm, adjust the feeder accordingly. To maintain a bromine residual, adjust the brominator feed rate to assure a constant treatment level of 1.0 to 3.0 ppm in residential pools and 3.0 to 5.0 ppm in commercial pools (normally, 30 to 180 grams of this product per 10,000 gallons daily).
